There are several working groups within this committee, including: 1) Events working group which organizes social and networking events to deepen the relationships of our members; 2) Growing the Collaborative Circle working group which focuses on building relationships with other organizations outside of our membership (please don't miss the mixer on February 6 at the Brazen Fox at 5:30 with the Westchester Women's Bar Association); 3) our Mentor Program which connects more experienced members to mentor new members; and 4) our Lunch working group which organizes regional lunches for members to get to know one another better.
- Newsletter Committee: Chaired by Randy Heller. The newsletter is shared every other month and provides important updates, articles, and highlights member accomplishments.
- Bylaws and Protocols Committee: Chaired by Tony Markus. This committee updates our bylaws, and develops and streamlines ethical and procedural standards to guide Collaborative practitioners.
- Racial Equity Committee: Chaired by Jessica Rothberg. This committee supports NYACP
 members in understanding the personal and professional impacts of systemic racism through
 self-reflection and education. The committee offers programs which promote inclusivity and
 equip members to better collaborate with historically excluded individuals. The goal is to build a
 safer community and create a membership that reflects the diversity of the greater New York
 area.
- 2025 Gala Committee: Chaired by Melissa Goodstein. This committee is planning and coordinating our 25th Anniversary Gala event on December 4, 2025, to honor NYACP's legacy, engage its membership, and highlight the organization's achievements.

In addition to our many committees, each region has a Pod group which meets regularly on Zoom. The New York City Pod is chaired by Judy Stein, the Long Island Pod is chaired by Nancy Kaye and the Northern Westchester Pod is chaired by Melissa Goodstein. All members are welcome to participate in all regional Pod presentations.
